THE CONFERENCE BOARD LEADING ECONOMIC INDEX® (LEI) FOR AUSTRALIA AND RELATED COMPOSITE ECONOMIC INDEXES FOR JUNE 2014

The Conference Board Leading Economic Index[®] (LEI) for Australia increased 0.4 percent and **The Conference Board Coincident Economic Index**[®] (CEI) increased 0.2 percent in June.

- The Conference Board LEI for Australia increased in June with six of the seven leading components making a positive contribution. With this month's increase, the six-month growth rate in the leading economic index between December 2013 to June 2014 stands at 1.5 percent (about a 3.0 percent annual rate), down from 2.6 percent (about a 5.3 percent annual rate) for the previous six months. However the strengths among the leading indicators have continued to outweigh the weaknesses, over the past six months.
- The Conference Board CEI for Australia, a measure of current economic activity, increased 0.2 percent in June. The coincident economic index grew 1.3 percent (about a 2.6 percent annual rate) in the six-month period through June 2014, up from 0.7 percent (about a 1.5 percent annual rate) in the previous six months. Meanwhile, real GDP increased at a 4.5 percent annual rate in the first quarter of 2014, up from 3.2 percent (annual rate) in the fourth quarter of 2013.
- The Conference Board LEI for Australia increased in June, after remaining relatively flat over the previous few months. As a result, its six-month growth rate has declined in recent months compared to the latter half of 2013. Meanwhile, the six-month growth rate of the CEI for Australia has changed little in recent months, but is improved compared to six months ago. Taken together, the recent behavior of the composite indexes suggests that economic expansion is not likely to accelerate in the near term.

<u>LEADING INDICATORS.</u> Six of the seven components that make up The Conference Board LEI for Australia increased in June. The positive contributors to the index — in order from the largest positive contributor to the smallest — are the sales to inventories ratio*, the yield spread, rural goods exports, building approvals, money supply*, and gross operating surplus*. Share prices declined in June.

With the 0.4 percent increase in June, The Conference Board LEI for Australia now stands at 130.2 (2004=100). Based on revised data, this index increased 0.2 percent in May and declined 0.1 percent in April. During the six-month period through June, the leading economic index increased 1.5 percent, and five of the seven components increased (diffusion index, six-month span equals 71.4 percent).

<u>COINCIDENT INDICATORS</u>. Three of the four components that make up The Conference Board CEI for Australia increased in June. The increases - in order from the largest positive contributor to the smallest – occurred in household gross disposable income*, employed persons and industrial production*. Retail trade declined in June.

With the increase of 0.2 percent in June, The Conference Board CEI for Australia now stands at 125.2 (2004=100). Based on revised data, this index remained unchanged in May and increased 0.1 percent in April. During the six-month period through June, the coincident economic index increased 1.3 percent, with all four components in the series making positive contributions (diffusion index, six-month span equals 100.0 percent).

<u>DATA AVAILABILITY.</u> The data series used to compute **The Conference Board Leading Economic Index**[®] (LEI) for Australia and **The Conference Board Coincident Economic Index**[®] (CEI) for Australia reported in this release are those available "as of" 10 A.M. ET on August 18,2014. Some series are estimated as noted below.

Series in The Conference Board LEI for Australia that are based on our estimates are sales to inventory ratio and gross operating surplus for private non-financial corporations, the implicit price index used to deflate rural goods exports and building approvals, and the CPI used to deflate money supply M3. Series in The Conference Board CEI for Australia that are based on our estimates are industrial production and household disposable income. CPI was used to deflate retail trade.

THE CYCLICAL INDICATOR APPROACH. The composite economic indexes are the key elements in an analytic system designed to signal peaks and troughs in the business cycle. The leading and coincident economic indexes are essentially composite averages of several individual leading or coincident indicators. (See page 3 for details.) They are constructed to summarize and reveal common turning point patterns in economic data in a clearer and more convincing manner than any individual component—primarily because they smooth out some of the volatility of individual components.

Historically, the cyclical turning points in The Conference Board LEI for Australia have occurred before those in aggregate economic activity, while the cyclical turning points in The Conference Board CEI for Australia have occurred at about the same time as those in aggregate economic activity.

Notes:

The component factors are inversely related to the standard deviation of the month-to-month changes in each component. They are used to equalize the volatility of the contribution from each component and are "normalized" to sum to 1.

These factors were revised effective with the release in January 2014, and all historical values for the two composite economic indexes have been revised at the time to reflect the changes. (Under normal circumstances, updates to the leading and coincident economic indexes only incorporate revisions to data over the past six months.) The factors above were calculated using 1979 to 2012 as the sample period for measuring volatility for The Conference Board LEI for Australia, and 1982 to 2012 as the sample period for The Conference Board CEI for Australia. There are additional sample periods as the result of different starting dates for the component data. When one or more components are missing, the other factors are adjusted proportionately to ensure that the total continues to sum to 1. The trend adjustment factor for The Conference Board LEI for Australia is -0.0463 calculated from 1960-1973, and -0.1239 calculated over the sample period 1974-2012.

To address the problem of lags in available data, those leading and coincident indicators that are not available at the time of publication are estimated using statistical imputation. An autoregressive model is used to estimate each component. The resulting indexes are constructed using real and estimated data, and will be revised as the data unavailable at the time of publication become available. Such revisions are part of the monthly data revisions, now a regular part of the U.S. Business Cycle Indicators program. The main advantage of this procedure is to utilize in the leading economic index the data, such as stock prices, that are available sooner than other data on "real" aspects of the economy, such as new orders and changes in inventory. Empirical research by The Conference Board suggests there are real gains in adopting this procedure to make all the indicator series as up-to-date as possible.


