Other books include *HR Leadership* (2009), *Aligning HR and Business Strategy* (1999, 2001 and 2009), *The High Performance Organization* (2005), *Understanding Change: theory, implementation and success* (2005) and *Motivating People in Lean Organisations* (1997). She is chief editor of Croner's online *HR Briefings*, and a member of several editorial boards.

A regular speaker at national and international conferences, Linda is Visiting Professor of Leadership Innovation at the University of Bedfordshire, Visiting Professor in HRM and Organisation Development at Cass Business School (London) and Adjunct Professor (Executive Education) at Imperial College, London. Linda is also a Visiting Fellow of the UK Commission for Employment and Skills, Fellow of Roffey Park, an Associate of Ashridge Management College and Erasmus Business School (Rotterdam). Linda is a member of several advisory boards, a Chartered Fellow of CIPD, a Fellow of both the RSA and the Institute of Leadership and Management (ILM).
