**THE CONFERENCE BOARD LEADING ECONOMIC INDEX®**  
**(LEI) FOR THE UNITED STATES**  
**AND RELATED COMPOSITE ECONOMIC INDEXES FOR JULY 2019**

**The Conference Board Leading Economic Index® (LEI)** for the U.S. increased 0.5 percent, **The Conference Board Coincident Economic Index® (CEI)** increased 0.2 percent and **The Conference Board Lagging Economic Index® (LAG)** increased 0.6 percent in July.

- The Conference Board LEI for the U.S. increased in July, driven by positive contributions from building permits, initial claims for unemployment insurance (inverted) and the financial components. However, the yield spread remained negative for a second consecutive month. In the six-month period ending in July, the leading economic index increased 0.8 percent (about a 1.6 percent annual rate), around the same rate of growth as over the previous six months. In addition, the strengths among the leading indicators remain more widespread than weaknesses.
- The Conference Board CEI for the U.S., a measure of current economic activity, also increased in July. The coincident economic index rose 0.6 percent (about a 1.1 percent annual rate) between January and July, half as fast as its growth of 1.2 percent (about a 2.5 percent annual rate) over the previous six months. Also, the strengths and weaknesses among the coincident indicators are now balanced. The lagging economic index continued to increase, but at a higher rate than the CEI. As a result, the coincident-to-lagging ratio declined. Real GDP expanded at a 2.1 percent annual rate in the second quarter of the year, after increasing 3.1 percent (annual rate) in the first quarter.
- The Conference Board LEI for the U.S. increased in July, after two consecutive moderate declines. As a result, its six-month growth improved somewhat but remains unchanged compared to six months ago. Meanwhile, The Conference Board CEI for the U.S. has also been rising slowly through July, but its six-month growth rate has slowed. Taken together, the current behavior of the composite indexes and their components suggest that the expansion in economic activity should continue in the near-term, but at a modest pace.

**LEADING INDICATORS.** Five of the ten indicators that make up The Conference Board LEI for the U.S. increased in July. The positive contributors – beginning with the largest positive contributor – were building permits, average weekly initial claims for unemployment insurance (inverted), stock prices, the Leading Credit Index™ (inverted), and average consumer expectations for business conditions. The negative contributors – beginning with the largest negative contributor – were the ISM® New Orders Index, average weekly manufacturing hours, the interest rate spread, and manufacturers’ new orders for nondefense capital goods excluding aircraft\*. Manufacturers’ new orders for consumer goods and materials\* held steady in July.

The LEI for the U.S. increased 0.5 percent in July and stands at 112.2 (2016=100). Based on revised data, this index decreased 0.1 percent in June and decreased 0.1 percent in May. Over the six-month span through July, the leading economic index increased 0.8 percent, with seven out of ten components advancing (diffusion index, six-month span equals 70 percent).

**COINCIDENT INDICATORS.** Three of the four indicators that make up The Conference Board CEI for the U.S. increased in July. The positive contributors to the index – beginning with the largest positive contributor – were employees on nonagricultural payrolls, personal income less transfer payments\* and manufacturing and trade sales\*. The negative contributor was industrial production.

The CEI increased 0.2 percent in July and stands at 106.2 (2016=100). Based on revised data, this index increased 0.2 percent in June and increased 0.1 percent in May. During the six-month period through July, the coincident economic index increased 0.6 percent, with two out of four components advancing (diffusion index, six-month span equals 50.0 percent).

**LAGGING INDICATORS.** The Conference Board Lagging Economic Index for the U.S. increased 0.6 percent and stands at 108.5 (2016=100) in July, with four of its seven components advancing. The positive contributors to the index – beginning with the largest positive contributor – were the average duration of unemployment (inverted), change in CPI for services, commercial and industrial loans outstanding\*, and the ratio of consumer installment credit outstanding to personal income\*. The negative contributor was the change in the index of labor cost per unit of output, manufacturing\*. The ratio of manufacturing and trade inventories to sales\* and the average prime rate charged by banks held steady in July. Based on revised data, the lagging economic index increased 0.5 percent in June and decreased 0.1 percent in May.

#### **DATA AVAILABILITY AND NOTES.**

The data series used to compute **The Conference Board Leading Economic Index®** (LEI) for the U.S., **The Conference Board Coincident Economic Index®** (CEI) for the U.S. and **The Conference Board Lagging Economic Index®** (LAG) for the U.S. and reported in the tables in this release are those available “as of” 2:30 pm ET on August 19, 2019. Some series are estimated as noted below.

\* Series in The Conference Board LEI for the U.S. based on our estimates are manufacturers’ new orders for consumer goods and materials and manufacturers’ new orders for nondefense capital goods excluding aircraft. Series in The Conference Board CEI for the U.S. that are based on our estimates are personal income less transfer payments and manufacturing and trade sales. Series in The Conference Board LAG for the U.S. that are based on our estimates are manufacturing and trade inventories to sales ratio, the change in labor cost per unit of output, manufacturing, consumer installment credit to income ratio, and the personal consumption expenditure deflator used to deflate commercial and industrial loans outstanding.

The procedure used to estimate the current month’s personal consumption expenditure deflator (used in the calculation of commercial and industrial loans outstanding) incorporates the current month’s consumer price index when it is available before the release of The Conference Board LEI for the U.S.

**THE CYCLICAL INDICATOR APPROACH.** The composite economic indexes are the key elements in an analytic system designed to signal peaks and troughs in the business cycle. The leading, coincident, and lagging economic indexes are essentially composite averages of several individual leading, coincident, or lagging indicators. (See page 3 for details.) They are constructed to summarize and reveal common turning point patterns in economic data in a clearer and more convincing manner than any individual component—primarily because they smooth out some of the volatility of individual components.

Historically, the cyclical turning points in The Conference Board LEI for the U.S. have occurred before those in aggregate economic activity, while the cyclical turning points in The Conference Board CEI for the U.S. have occurred at about the same time as those in aggregate economic activity. The cyclical turning points in The Conference Board LAG for the U.S. generally have occurred after those in aggregate economic activity.

Notes:

The component factors are inversely related to the standard deviation of the month-to-month changes in each component. They are used to equalize the volatility of the contribution from each component and are “normalized” to sum to 1. When one or more components are missing, the other factors are adjusted proportionately to ensure that the total continues to sum to 1.

These factors were revised effective with the release in February 2019, and all historical values for the three composite economic indexes were revised at this time to reflect the changes. (Under normal circumstances, updates to the leading, coincident, and lagging economic indexes only incorporate revisions to data over the past six months.) The factors for The Conference Board LEI for the U.S. were calculated using May 1990-December 2017 as the sample period for measuring volatility. A separate set of factors for the February 1959 - December 1977, January 1978 - December 1983 and January 1984 – April 1990 periods are available upon request. The primary sample period for the coincident and lagging economic indexes was February 1959 – December 2017. The trend adjustment factor for The Conference Board LEI for the U.S. is -0.0777 (over the 1984 – present) and 0.0940 (over the 1959-1983 period), and the trend adjustment factor for The Conference Board LAG for the U.S. is 0.1460.

To address the problem of lags in available data, those leading, coincident and lagging indicators that are not available at the time of publication are estimated using statistical imputation. An autoregressive model is used to estimate each unavailable component. The resulting indexes are therefore constructed using real and estimated data and will be revised as the unavailable data during the time of publication become available. Such revisions are part of the monthly data revisions, now a regular part of the U.S. Business Cycle Indicators program. The main advantage of this procedure is to utilize in the leading economic index data such as stock prices, interest rate spread, and manufacturing hours that are available sooner than other data on real aspects of the economy such as manufacturers’ new orders. Empirical research by The Conference Board suggests that there are real gains in adopting this procedure to make all the indicator series as up-to-date as possible.

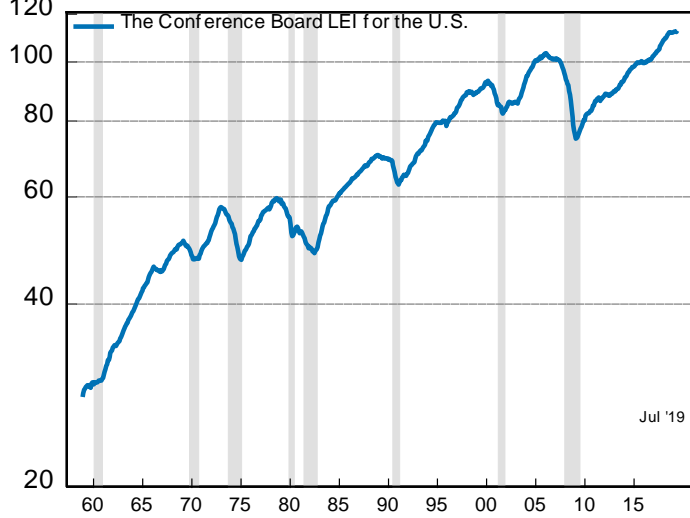

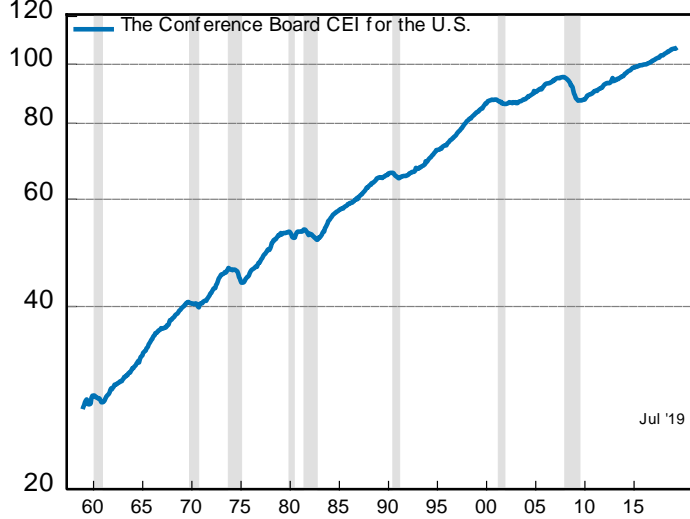

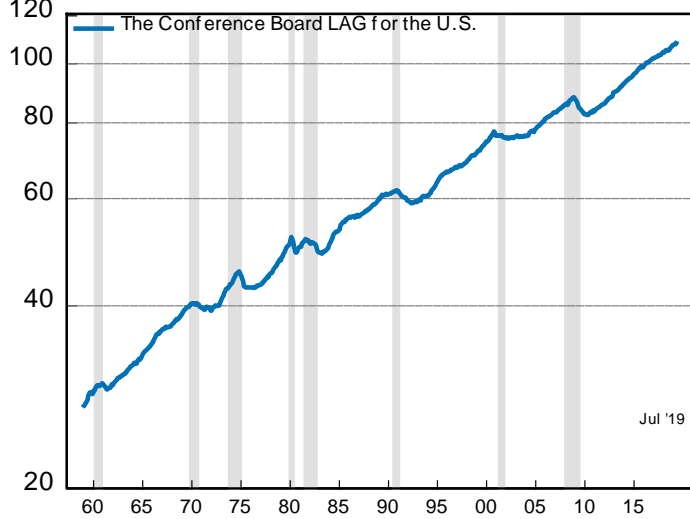
