WORK PLAN, EARLY CHILDHOOD EDUCATION

CED's Education Subcommittee on Early Childhood Education will launch a study on the national economic impact of the childcare industry; the report will describe the industry, demand, demographics, labor force participation rates, impact of subsidy as part of economic growth, and spillover effects of employment.

WORK PLAN, K-12

CED's Education Subcommittee on K-12 will continue its two-year initiative to support both high standards and a high-quality education system that prepares all students for college and the workplace (the Common Core State Standards).

WORK PLAN, POSTSECONDARY EDUCATION

CED's Education Subcommittee on Postsecondary Education will continue to work with California Lt. Governor Gavin Newsom, and other key stakeholders in the state to identify actionable reforms to improve California's broad access institutions. CED will also debut a research project identifying promising business practices for employee postsecondary degree attainment and certification in support of the Lumina Foundation's goal of reaching 60 percent college attainment by the year 2025. CED will document employer programs to support employees in degree attainment, and explore any barriers to such efforts that employers perceive.
