

Cookie Policy

Effective Date: May 23, 2018

This Cookie Policy is part of our [Terms of Use](#) and [Privacy Policy](#) and applies to you (“you”) when you access Conference-Board.org and our affiliated websites (e.g. CED.org, demandinstitute.org), mobile platforms, applications, and services (collectively, our “Sites”), regardless of the location from which you access them. Moreover, this Cookie Policy applies to all of our Sites, regardless of how you access or use our Sites, including through mobile devices.

About cookies

Cookies are small data files which are downloaded to your device when you visit our Sites and allow us to recognise your device. Cookies may gather information about your use of our Sites or may enable us to recognise you as an existing customer when you return to our Sites at a later date. This information includes computer and connection information such as statistics on your page views, traffic to and from our Sites, referral URL, your internet protocol address, and device identifiers; this information may also include your browsing history, transaction history, and your web log information.

You can choose to disable cookies in your browser, however, if cookies are disabled, not all features of our Sites will operate as intended. For example, you may not be able to use all the features we offer, you may not be able to store your preferences and some of our pages may not display properly. You can find more information on how to disable and/or delete cookies in section 3 below.

1. What types of cookies are used?

We use both session cookies (automatically deleted when you close your browser or app) and persistent cookies (remain stored on your device) on our website and our mobile platform.

We also use first party cookies (which are set by us) and third-party cookies (which are not set by us, but by a server located outside the domain of our site).

We use cookies for:

- **Strictly necessary purposes** – these are essential to enable you to move around our website and our mobile platform, and use its features
- **Analytics and performance-related purposes** – these collect information about how you use our Sites, for example which webpages/features you go to most often. This allow us to improve how the Sites work.

- **Functionality purposes** – to remember your preferences, settings and other functionalities you may request (such as your login details)

2. List of Cookies used on this website

The following list categorises and describes the various cookies used on this website and mobile platform and the purposes for which they are used:

i. Coldfusion cookies

- Name: CFID, CFTOKEN, JSESSIONID, tcb_login, hwo_report, cci_report, eti_report
- Purpose: These cookies are necessary to enable logins on the website and recognize users. They allow you to set preferences, and to remain logged in. Without these cookies, this process would be impossible.
- Cookie owner: first party
- Cookie type: recognition/ functionality

ii. Google Analytics cookies

- Name: _ga, _gid, _gat, AMP_TOKEN, _gac_<property-id>, _dc_gtm_<property-id>
- Purpose: These Cookies are used to collect information about how visitors use this website. We use the information to compile reports and to help us improve this website. The Cookies collect information in an anonymous form, including information on the number of visitors to this website, from where visitors came to this website and the pages they visited.
- Cookie owner: third party
- Cookie type: analytics / performance cookie
- Information: The information generated by the Cookie about your use of this website (including your IP address) will be transmitted to and stored by Google on servers in the United States. For more information about Google cookies, please read the Google Privacy Policy.
